The proposed modified map fails to preserve the landscape buffer area of woodland between the proposed residential area for AL/BM2 and the village hall. In this respect it differs materially from PS 069 the Brenchley and Matfield Neighbourhood Development Plan's map (figure 20, page 38) for this site, and from the drawings P (0)107 Rev D Block Plan and P(0) 400 Rev A Landscape Strategy that were listed in the resolution to grant planning permission for application 22/00757/FULL, in that the residential area is now shown extending right up to the village hall's southern boundary, instead of leaving a landscape buffer area of woodland between the residential area and the village hall. The removal of this area of trees from the map would also conflict with subparagraphs c and d of Policy H8 of the Neighbourhood Development Plan, as it would damage the landscape character of the village and would not safeguard existing trees.

Drawings P(0) 107 Rev D Block Plan and P(0) 400 Rev A Landscape Plan from planning application 22/00757/FULL are attached to the covering email submitting the Parish Council's representations.

The Parish Council understands that the removal of the landscape buffer between the proposed residential area and the village hall area may have been an accidental mapping error on the northern boundary of the residential area while the western and southern boundaries of the residential area were being amended to reflect the planning permission.
