The highway improvements identified to facilitate the new housing proposed for Pembury are inadequate. The capacity of the crossroads at Woodsgate Corner is only a small part of the existing wider traffic problem which includes the two roundabouts at Kippings Cross.

The main issue is the capacity of A264 Pembury Road itself further along towards Royal Tunbridge Wells town centre which is already severely congested. Although there are projects listed as critical in the Infrastructure Delivery Plan [eg traffic signals at Sandhurst Road junction] these will be very difficult to achieve during the plan period because there isn't enough highway land available for extra lanes and road widening there. Bus journey times can't be improved either without increasing the highway capacity.
