1. Provide further details of the inability to provide alternative locations with sufficient infrastructure.

2. Set out a process for establishing contractural arrangements with House builders capable of successfully developing this site.

3. Obtail detailed agreement with Kent County Council on the provision of infrastructure with costings (at todays prices). Establish the ability to raise these funds from the uplist of land values. Obtain agreement of the current land owners.

4. Develop alternative transport link of light electrical vehicles along the equivalent of a cyctle path following existing cycle routes. These should provide direct links to both Tunbridge Wells and Tonbridge. These costs can be kept modest and economic.
