The proposed new development at Queen Street by Redrow and Persimmon presents serious issues with flooding of Paddock Wood from the Rhoden stream. The developers wish to develop a new sewage works, which will deposit a minimum of 50,000 L a day into this small stream to serve the development over the last few years. This stream has had to endure development on Green Lane, where its floodwaters flow into the Rhoden stream, and also the development in Church Road, which also places its surface water into the road and stream.

Rhoden stream can only take so much water and there are additional issues with dams by the railway being flooded as well as the stream and the railway culvert not being large enough to accommodate the excessive amount of water when there are heavenly heavy rainfalls. There's been no upgrade of the stream, no upgrade of the culvert and of the ditches and streams on the opposite side of these culverts

Apparently, the council has stated that placing strategic development in area of flood risk would improve flooding issues in the area as we which really defies all logic. As the town council has explained previously the borought council blurs together wastewater, freshwater infrastructure and surface water, all causing flooding of different types at different times. Reference to the river flooding only represents a misunderstanding on the council part of the difference between these very different and very critical issues for Paddock Wood.

Betterment was promised by Tunbridge Wells Borough Council on the three strategic sites now under construction. However, in reality, the sewage system has been further over burden and regularly overflows. nt works.

It is noted that due to the lack of a clear master planning approach, it has resulted in the Swatlands employment site to be approved before the local plan is adopted. The new flood risk evidence indicates that this site might not have been approved at the council following the evidence and the requirements of the NPPF.

Why are SUDs not required on the current building on Mascalls Grange in particular? All drives should be permeable. To <u>assume</u> that surface water will be dealt with is a nonsense. The water table in out garden in about 3 inches below ground, and we are not in a flood zone.
