I remain concerned that the council has not undertaken sufficient, effective consultation with neighbouring local authorities, or with the Paddock Wood Town Council which represents the people most impacted by this draft plan. The plan remains unsound. Insufficient consideration has been given to alternatives to strategic growth at Paddock Wood including east Capel, there is a lack of critical infrastructure to support the proposed significant and excessive expansion of Paddock Wood, existing residents of Paddock Wood will be adversely impacted, and the proposals do not mitigate these. Specifically, there is insufficient consideration of the increased risk of surface water flooding from the proposed additional development – this will particularly impact on existing residents, the existing water and sewage services are already unable to cope with the level of housing in Paddock Wood. The is no mention of providing additional medical services in Paddock Wood – the existing surgery has already been forced to close its books to new patients.

Whilst I support the removal of the Tudeley Garden Village from the draft plan, and also support the reduction in proposed housing in Paddock Wood including east Capel, significant changes are still required for the local plan to be fit for purpose. The Tudeley village should be removed completely as a possible site – as drafted the plan leaves future development as an option. Even in the limited cases where additional infrastructure for and around Paddock Wood has been included – there are either unrealistic costings which will reduce the likelihood they will happen, or there is no clear approach to ensuring the necessary infrastructure or sevices improvements are in place BEFORE further development. Paddock Wood has already been subject to significant increase in housing without the infrastructure changes – for example just look at the stop gap approach to increasing sewerage facilities where we were promised a more future proofed project than was delivered,

Green Belt - I do not support the proposal to declassify east capel as green belt land. This land should be protected. I do not consider that you have demonstrated the necessary exceptional circumstances. Bypass of Colts Hill - I am concerned that the proposed bypass of colts hill will have irrevocable damage on local wildlife and biodiversity. The costings provided are significantly different to those previously provided with no explanation about why this is the case. Paddock Wood strategic growth - whilst I support the reduction in development and not developing on flood zone 2 and 3 areas, this needs to be future proofed. Consideration of surface water flooding issues needs to be fully included – some of the land proposed for development even under the new proposals floods during periods of significant rain. The knock on impacts on existing housing in Paddock Wood has not been fully taken into account. The updated proposals do not address issues previously raised regarding the imperative that infrastructure improvements are delivered BEFORE further development. Recent projects to improve sewerage in Paddock Wood have only addressed pre existing issues - they were not designed for a further very significant increase in housing. There is a lack of medical facilities in Paddock Wood – the level of proposed development without an increase in GP and other medical facilities is unacceptable. The proposed changes now completely disregard the need for development of Paddock Wood Town centre - the lack of retail space - caused at least partly by the approvals for development on retail space compromises the aims of the Neighbourhood plan to have a thriving community. Indeed the recently agreed neighbourhood plan has been completely disregarded. Transport – proposals to change traffic over the railway bridge, and potentially make it one way, will have a significant NEGATIVE impact on Paddock Wood, its businesses and its residents - I DO NOT support this. It

has clearly been suggested by someone who have never experienced the reality of living in paddock wood.

Environment – I do not consider that enough consideration has been given over the environmental impact, and specifically the impacts on biodiversity, of the proposed developments. The area that is being proposed for development is rich in biodiversity, with a wide range of birds and small mammals that should be protected. The retention of hedgerows and trees should be a prerequisite for any development, with any developer who removes them immediately forfeiting their right to continue to develop the land.

Sporting facilities – while I support the proposal for a swimming pool to be built in Paddock Wood, I have no confidence that these facilities will actually appear. The level of proposed increase in sporting/leisure facilities is not commensurate with the number of additional homes proposed.

There have been changes to the national planning policy framework – these have not been taken into account in the draft plan. TWBC needs to stand up for its local residents. It is unfair that TWBC are proposing to force 50% of the proposed additional housing on Paddock Wood, thereby fundamentally changing the character of what was until recently a large village.

It is unclear what TWBC mean by undertaking an immediate review of the local plan as soon as this one is agreed – all that means is that the decisions that are being made will be potentially unmade, with the potential (likelihood) for even more unsustainable development to be proposed.

More needs to be done to force developers who gain planning permission to deliver on that, and not bank land, and priority should be given to brownfield development NOT digging up of green fields, particularly in green belt.

Additionally I support the comments made by Paddock Wood Town Council.
