Attenuation ponds do not address the real issue as stated in my earlier remarks about the Gravely way stream and the Tudeley Brook Stream. These waters do not start in Paddock Wood they start from Matfield and Pembury and the report does not reflect the graverty of this situation nor does it address them in Matfield nor Pembury, it tries to address them in Paddock Wood, which is not addressing the issue. Paddock Wood can cope with its own rain fall and should not be made to address others problems at Paddock Wood.

2nd Both ends of the Badsell road have hot spots which by KCC own addition they cannot address at this moment. Dampers corner roundabout is to expensive and would need compulsory orders put on land to accommodate the new roundabout, that's KCC own words.Badsell/ Maidstone road junction has a major issue of an under river flowing beneath the surface and a culvert so the straightening of this road cannot go ahead, again KCC said this in its report.

3rd where Paddock Wood finishes along Badsell road the new revised plan wishes to put right next to Paddock Wood Capels housing of 562 houses right in the middle of Badsell Road where road improvement are a must with two hotspots either end of this one road and which KCC have said they cannot do.

4th any housing that is built on the Badsell road will want to use PaddockWood facilities but any 106 money will not be attributed to Paddock Wood but rather Capel which will be unjust by any imagination
