I have huge concerns that the outdoor sports hub has been shelved, with all the new building that is proposed alongside the new houses that are already being built, the current facilities are no longer big enough to cope. Paddock Wood is in desperate need of bigger and better facilities including a 3G pitch, a second rugby pitch as a minimum, plus many more various size football pitches and training areas, plus keeping all the facilities in one place would be more manageable, plus carbon footprint friendly. The initial thoughts for the sports hub was to also include indoor sports plus a swimming pool all in one place, so that every member of the family could join together and local clubs could have a designated home, including cafe/bar. Residents of Paddock Wood would welcome such a facility.
