

## Proposed Changes to Tunbridge Wells Borough Council's Existing Policies Map and 'saved' policies

The current Development Plan presently consists of the policies adopted in the 2006 Local Plan (LP06) and 'saved' in the 2010 Core Strategy (CS10), new policies adopted within the 2010 Core Strategy, and those adopted in the 2016 Site Allocations Local Plan (SALP16; to meet the development strategy of the Core Strategy).

The current [Policies Map](#) presently consists of only those policies adopted in the 2006 Local Plan and 'saved' in the 2010 Core Strategy, and those adopted in the 2016 Site Allocations Local Plan.
